1. Disciplinary Panel Outcomes

1.1. NEC Panels have determined 636 investigations since 21 May 2020 or 118 investigations since the last report on 09 November 2021.

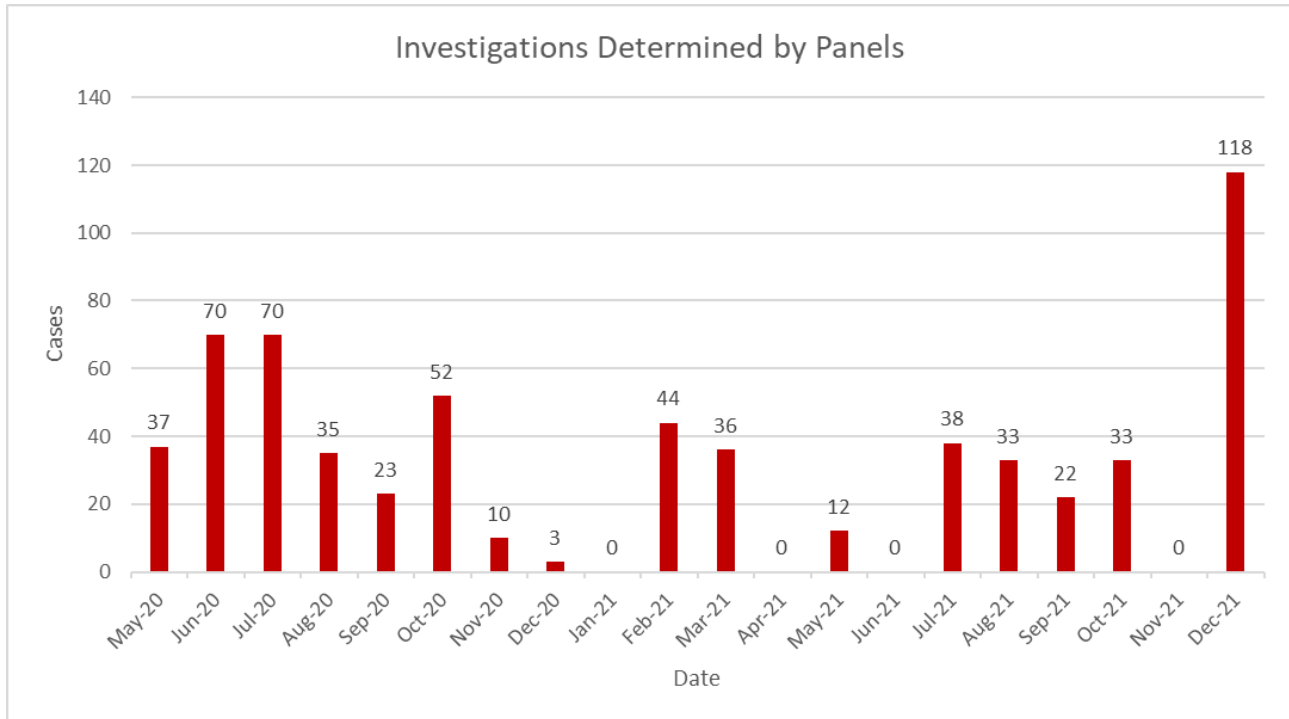


Figure 1: Investigations Determined between 21 May 2020 and 16 December 2021

Category of Cases

- 1.2. A case may belong to a number of different categories. For example, a case may involve allegations of both sexism and Islamophobia. In this example, the case would be recorded in both the sexism and Islamophobia categories in the statistics provided below, which means the overall percentage in each reporting category does not always amount to 100%."
- 1.3. Of the 636 cases determined by NEC Panels since 21 May 2020: 59.91% have involved allegations of antisemitism; 8.96% have involved constitutional matters; 7.39% have involved bullying, harassment, or intimidation; 5.03% have involved online conduct (e.g. abusive or unpleasant online conduct); 4.56% have involved some form of misconduct, typically elected representatives that have been subject to standards investigations or committed infractions of COVID restrictions; 3.93% have involved allegations of Islamophobia; 3.30% have involved allegations of anti-black racism; 2.83% have involved allegations of sexism; 1.26% have involved safeguarding allegations; 1.26% have involved allegations of sexual harassment.

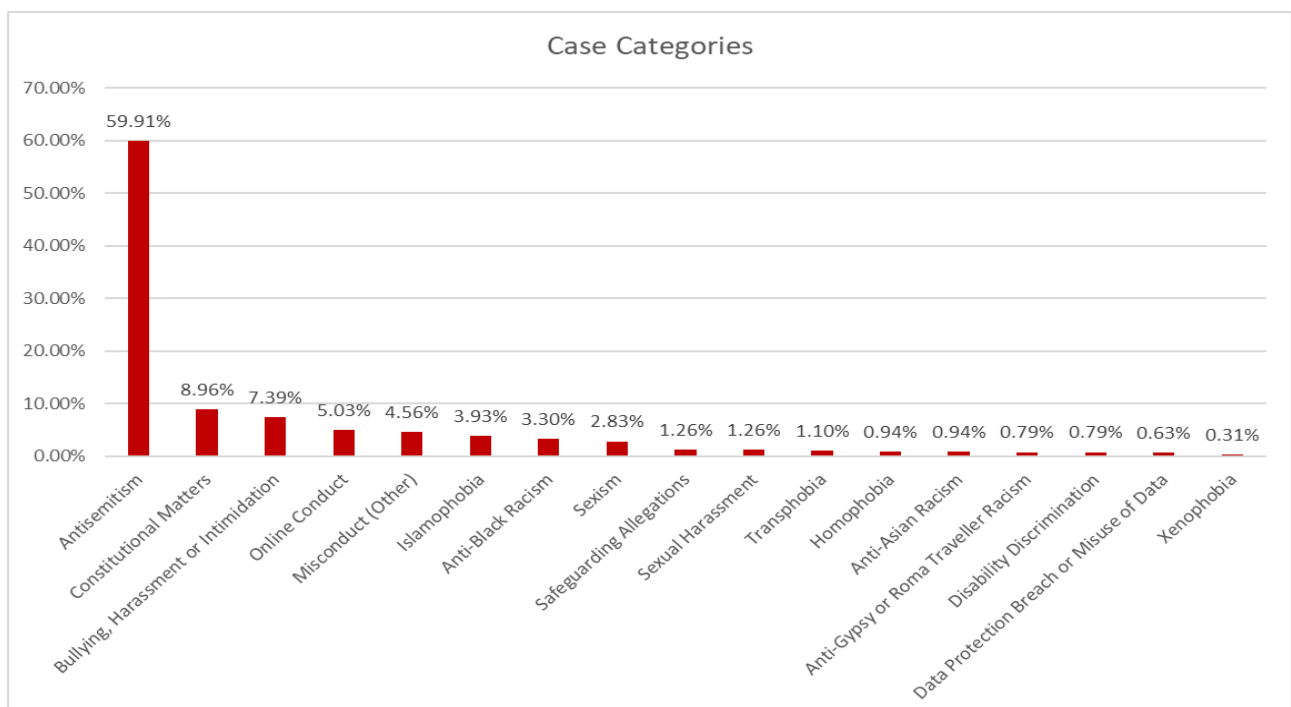


Figure 2: Types of case heard between 21 May 2020 and 16 December 2021

1.4. Of the 118 cases determined since the last report on 09 November 2021: 39.83% have involved allegations of antisemitism; 16.95% have involved online conduct; 13.56% have involved allegations of bullying, harassment or intimidation; 5.93% have involved allegations of misconduct; 5.08% have involved allegations of Islamophobia; 5.08% have involved allegations of sexual harassment; 2.54% have involved allegations of anti-black racism; 2.54% have involved allegations of homophobia; 2.54% have involved allegations of anti-Asian racism; 1.69% have involved allegations of disability discrimination; 1.69% have involved allegations of data misuse; and 0.85% have involved allegations of Sinophobia.

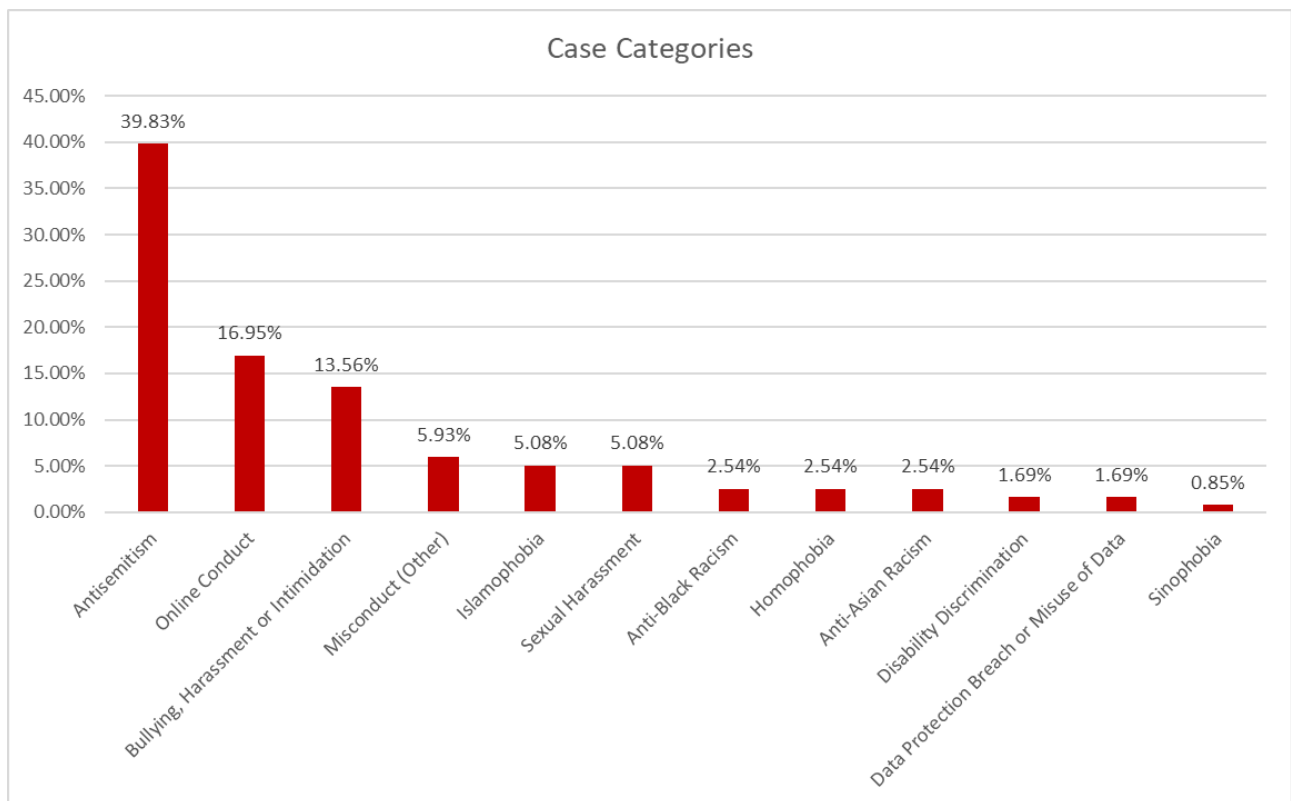


Figure 3: Types of case heard between 09 November 2021 and 16 December 2021

Disciplinary Outcomes

- 1.5. Of the 636 cases determined by NEC Disputes sub-panels since 21 May 2020: 19.97% have resulted in expulsion; 9.43% have resulted in some form of punitive suspension; 9.91% have been referred to the National Constitutional Committee; 21.28% have resulted in the issuing of an NEC Formal Warning; 19.18% have resulted in the issuing of a Reminder of Conduct; 8.49% have resulted in the issuing of a Reminder of Values; no further action was taken in 12.74% of cases.

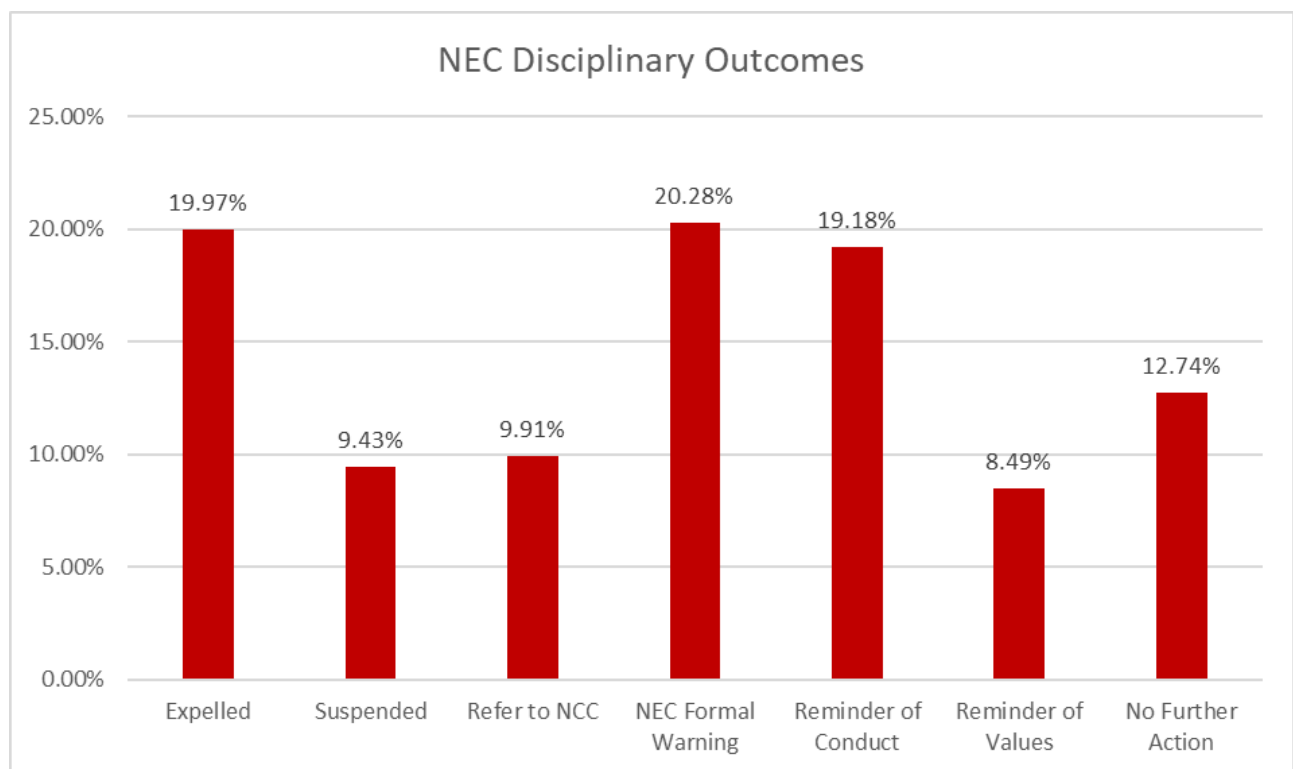


Figure 4: Outcomes between 21 May 2020 and 16 December 2021

1.6. Of the 118 cases determined by NEC Disputes sub-panels since the last report on 09 November 2021: 10.17% have resulted in expulsion; 8.47% have resulted in some form of punitive suspension; 10.17% have been referred to the National Constitutional Committee; 15.25% have resulted in the issuing of an NEC Formal Warning; 17.80% have resulted in the issuing of a Reminder of Conduct; 11.02% have resulted in the issuing of a Reminder of Values; no further action was taken in 27.12% of cases.

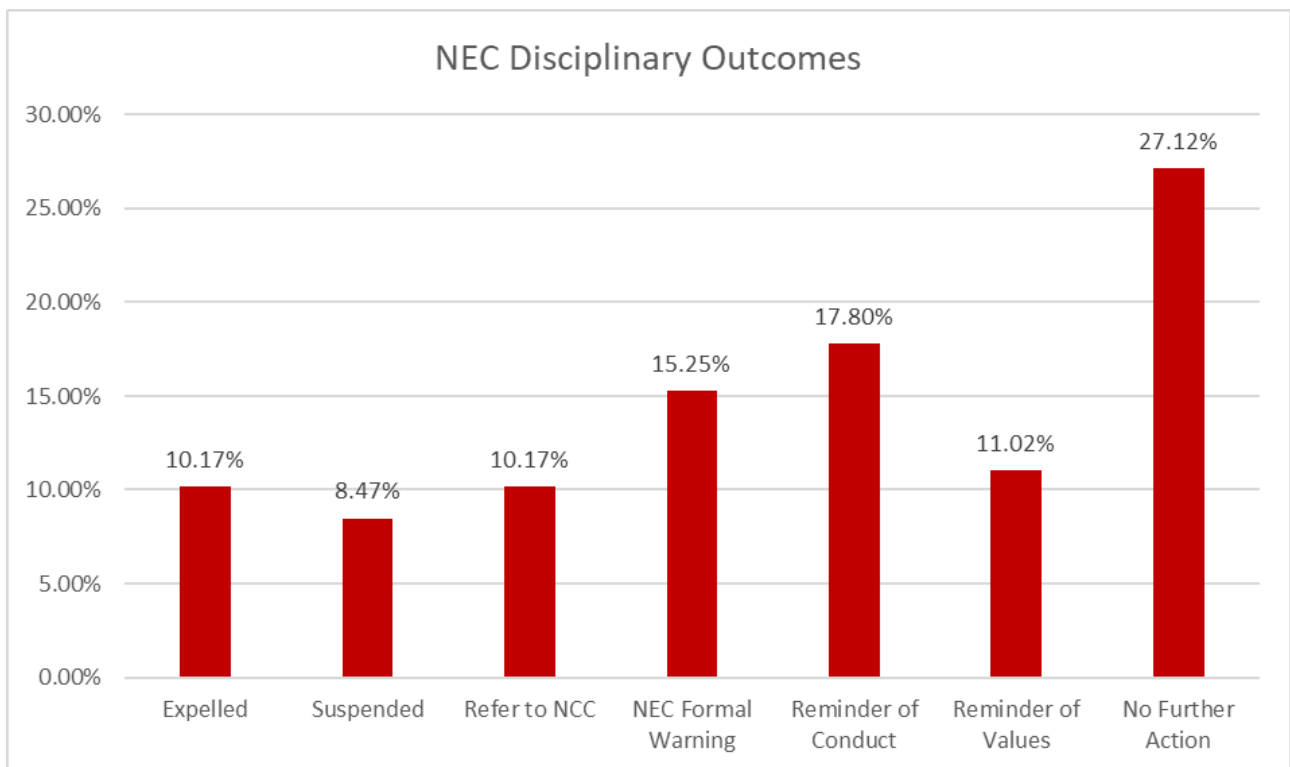


Figure 5: Outcomes between 09 November 2021 and 16 December 2021

2. Exclusions

2.1. Since exclusion panels began on 22 October 2021, 86 (+65 since the previous report) cases have been determined. Of these 86 cases:

2.1.1. 94% of the allegations were upheld and 6% of the allegations were not upheld.

2.1.2. 98% of the cases involved support for another political organisation (Chapter 2, Clause I.5.B.v). 2% involved a member being convicted of a serious criminal offence (Chapter 2, Clause I.5.B.viii).

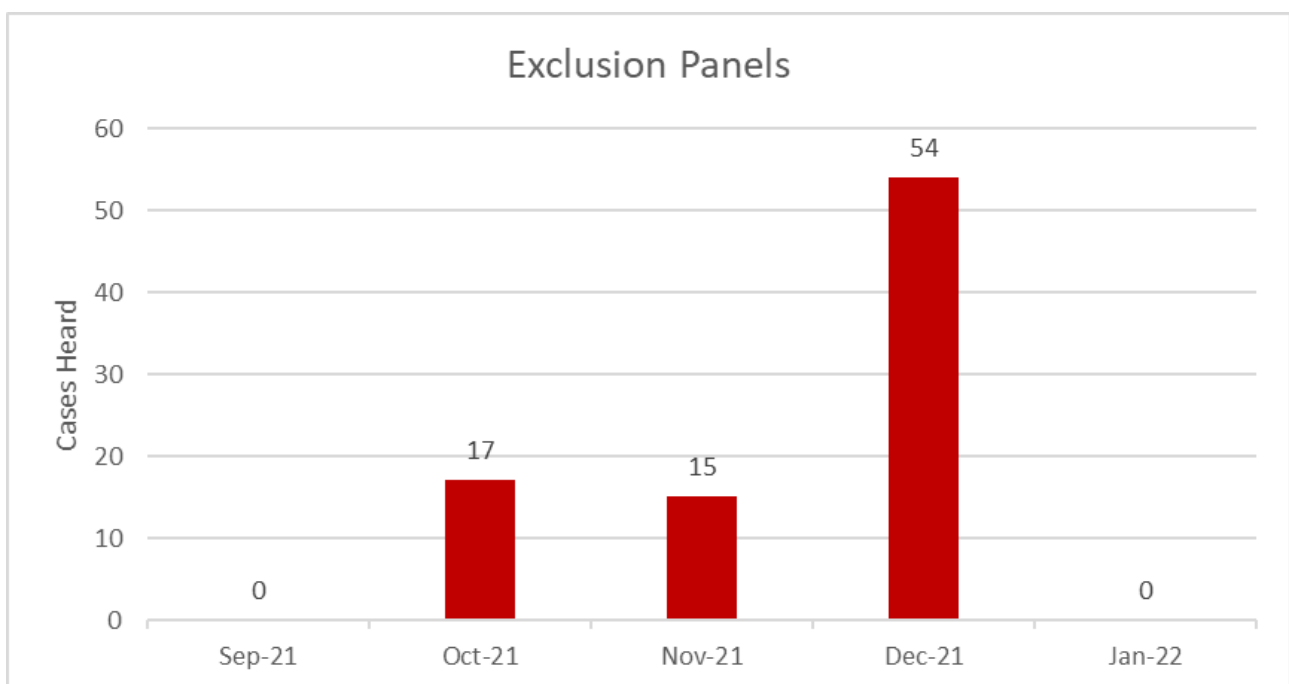


Figure 6: Exclusion cases heard between 22 October 2021 and 13 December 2021

2.2. Of the 98% of cases involving support for one or more proscribed political organisation: 58% involved support for Labour Against the Witchhunt; 33% involved support for Labour in Exile Network; 10% involved support for RESIST; and 43% involved support for Socialist Appeal.

3. Terminations

- 3.1. 2 (+2 since the previous report) people have had their membership terminated pursuant to Chapter 2, Clause I.4 of the Labour Party Rule Book since the previous report on 09 November 2021.

- 3.2. In both cases, this was for standing in an election against the Labour Party contrary to Chapter 2, Clause I.5.B.i of the Labour Party Rule Book.

4. National Constitutional Committee

- 4.1. 96 (+7 since the last report) that have been referred to the National Constitutional Committee have concluded since 10 March 2020. 27% went to a hearing; 44% lapsed before a hearing; 25% resigned before their hearing; and 4% were expelled or excluded for unrelated disciplinary offences.

- 4.2. There are 86 (+8) cases currently awaiting a hearing of the National Constitutional Committee. 3 of these have papers served and are currently awaiting a hearing. The papers for the rest of these cases are currently being worked on by officers.
