2 Disciplinary Panels

- 2.1. To date in 2025, panels of the National Executive Committee (**NEC Panels**) considered 11 cases investigated under Chapter 6, Clause I of the Labour Party Rule Book.

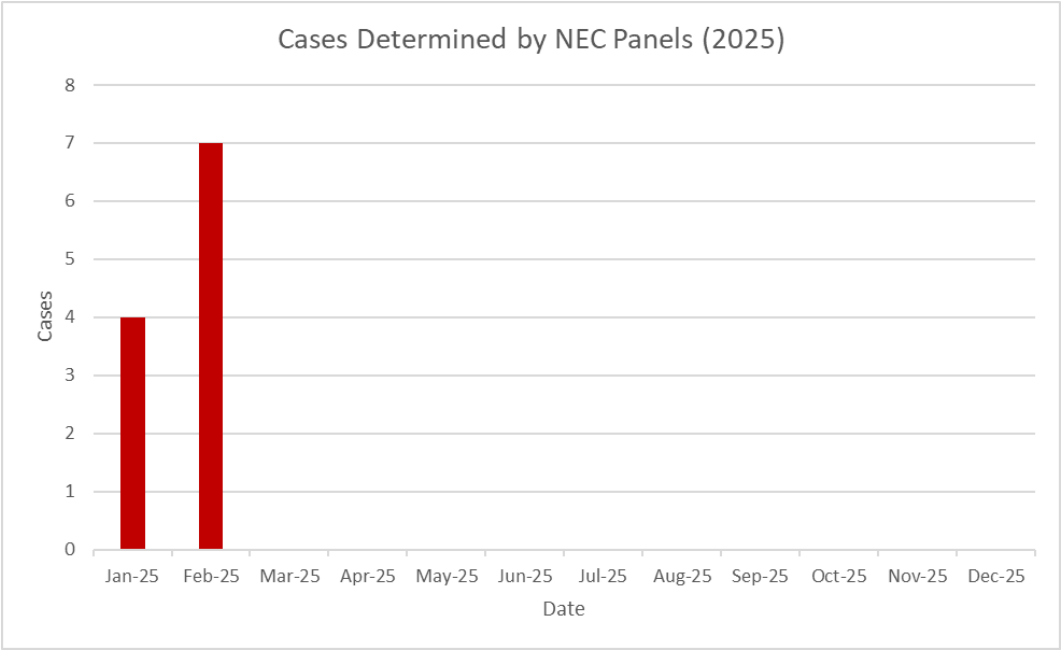


Figure 1: Cases determined by NEC Panels in 2025.

The Labour Party

Case Categories

- 2.2. To date, in 2025, around 45% of cases have involved general misconduct, 27% have involved bullying, around 9% have involved online misconduct, around 9% have involved constitutional matters, and around 9% have involved issues surrounding data.
- 2.3. These figures show the proportion of the total number of cases that allegations of each category are found in. For example, if there was only one case, and that case involved an allegation of antisemitism and an allegation of islamophobia, then the figures for both antisemitism and islamophobia would be 100%.

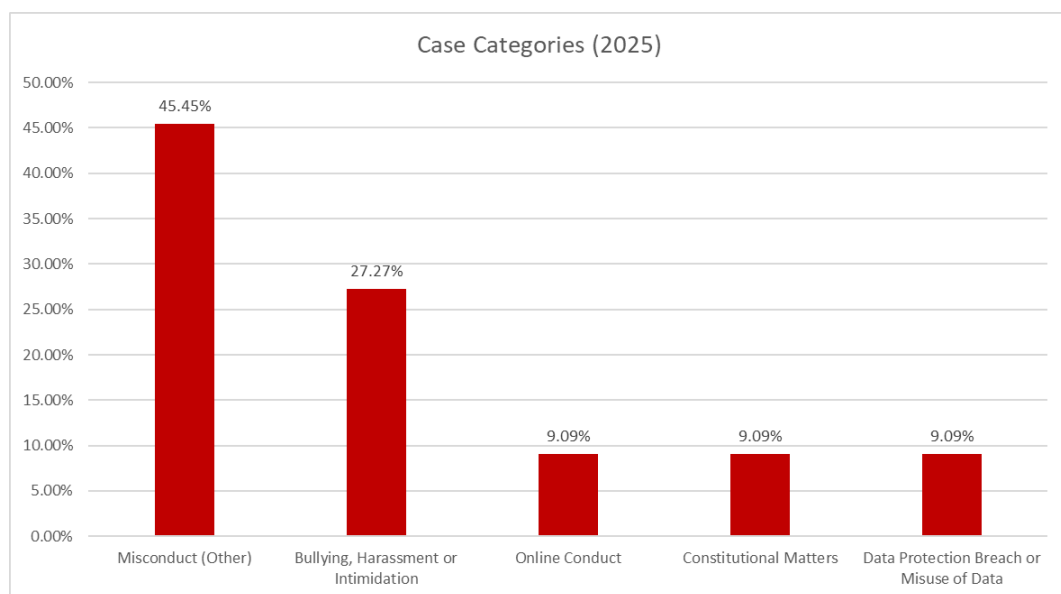


Figure 2: Types of case determined by NEC Panels in 2025.

The Labour Party

Case Outcomes

- 2.4. To date, in 2025, more than half (54.55%) of cases resulted in a referral to the National Constitutional Committee. 27.27% of cases resulted in a formal warning or a reminder of conduct. 18.18% of cases resulted in a reminder of values or no further action.

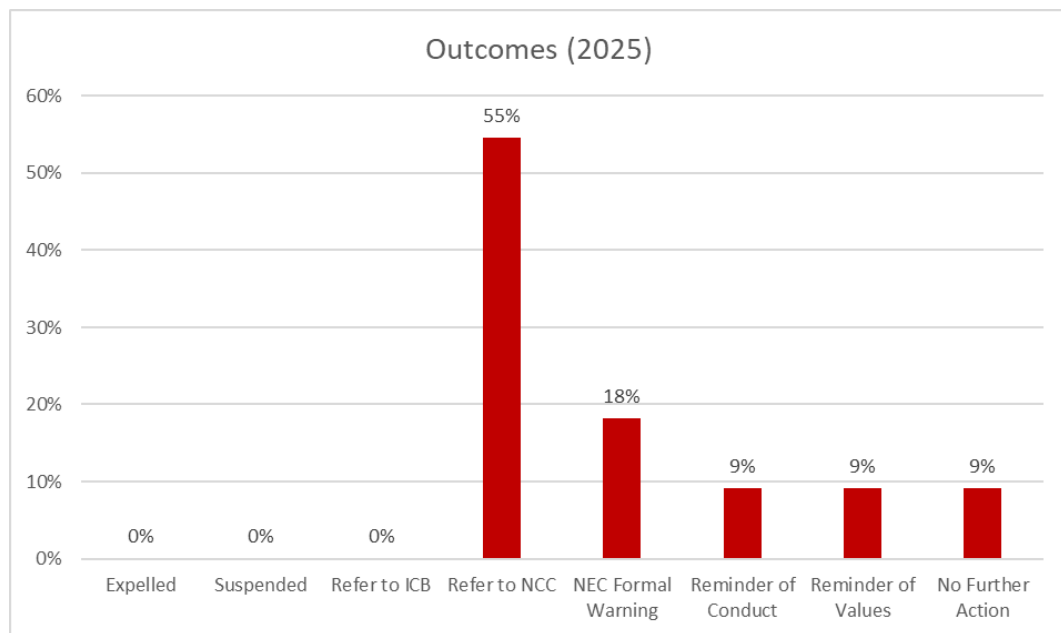


Figure 3: Outcomes of cases determined by NEC Panels in 2025.

3 Independent Review Board

3.1. To date, in 2025, no cases have been assessed by the Independent Review Board. This is because the panel in February dealing with protected characteristic cases had to be abandoned. Those cases are due to be heard on 6 March 2025.

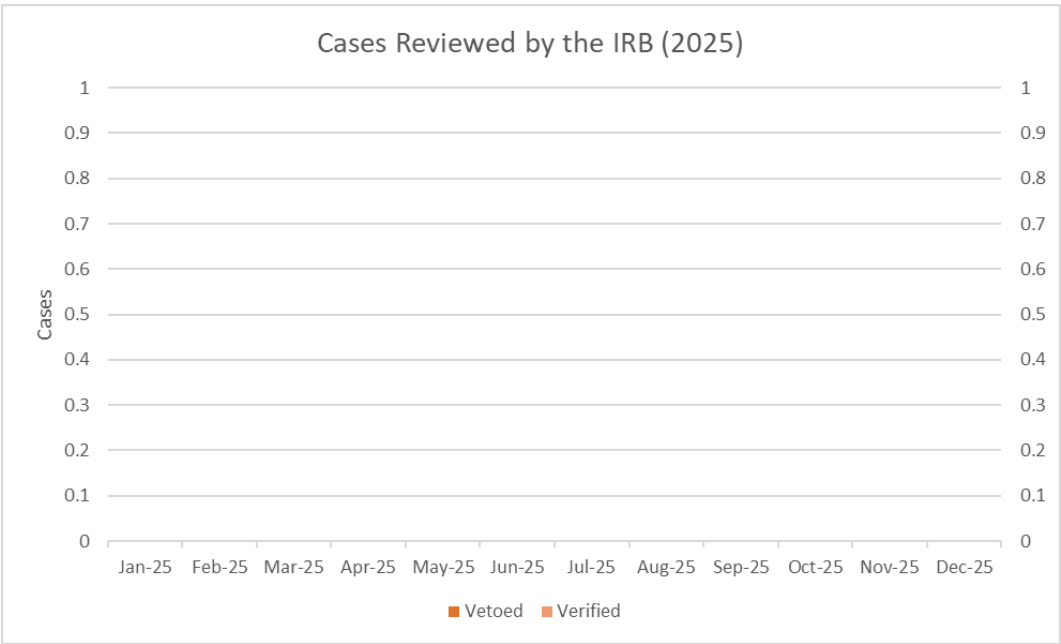


Figure 4: Cases reviewed by the Independent Review Board in 2025.

4 Exclusion Panels

- 4.1. To date, in 2025, NEC Panels considered 20 cases that had been investigated under Chapter 2, Clause I.5 of the Labour Party Rule Book.
- 4.2. Of these 20 cases, 17 allegations were upheld and the member was excluded; and in 3 cases, the allegations were not upheld (meaning the individual remains a member of the Labour Party).
- 4.3. Of these 20 cases, 18 involved an alleged breach of Chapter 2, Clause I.5.B.iv and vi (Support for an inimical political organisation or a candidate standing against the Labour Party), 1 involved an alleged breach of the Chapter 2, Clause I.5.B.vi (membership of another political party), and 1 involved an alleged breach of Chapter 2, Clause I.5.B.ix (convicted of a serious criminal offence).

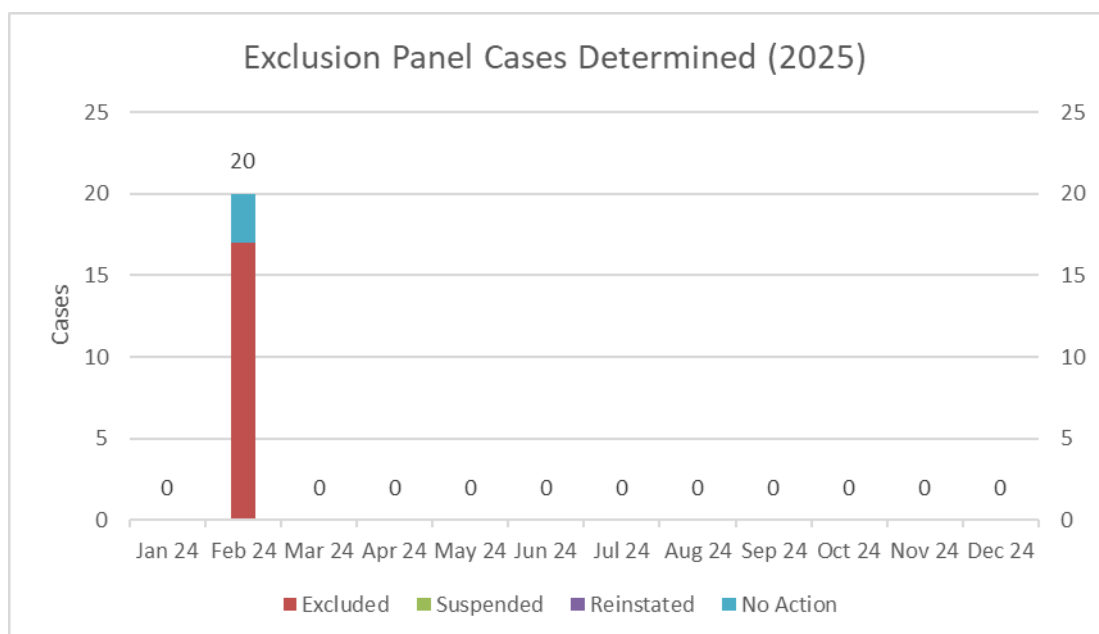


Figure 5: Cases determined by NEC exclusion panels in 2025.

5 Terminations

- 5.1. To date, in 2025, 4 members had their membership rights terminated pursuant to Chapter 2, Clause I.4 of the Labour Party Rule Book.
- 5.2. Of these 4 members, the membership rights of 3 individuals were terminated for signing the nomination papers of candidates standing against the Labour Party; and the membership rights of 1 individual was terminated for publicly declaring their intention to stand in an election against the Labour Party.

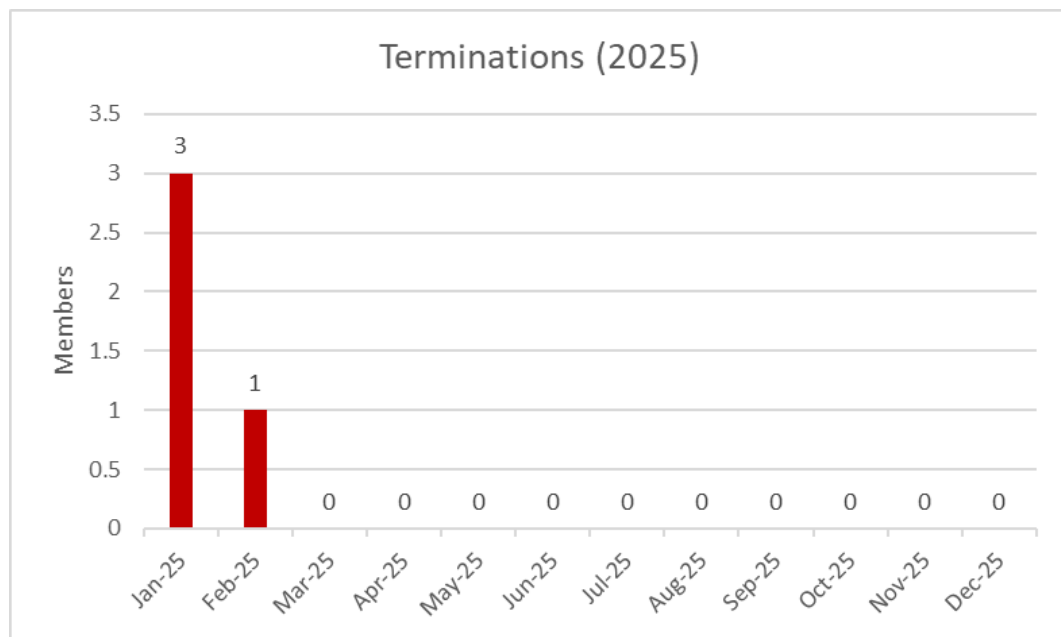


Figure 6: Membership terminations in 2025

6 Disciplinary Appeals

- 6.1. To date, in 2025, no appeals have been determined.
- 6.2. Appeal correspondence relating to 36 cases remains outstanding. Paperwork in respect to 18 of these appeals has been prepared, the other 18 cases are being prepared by officers.

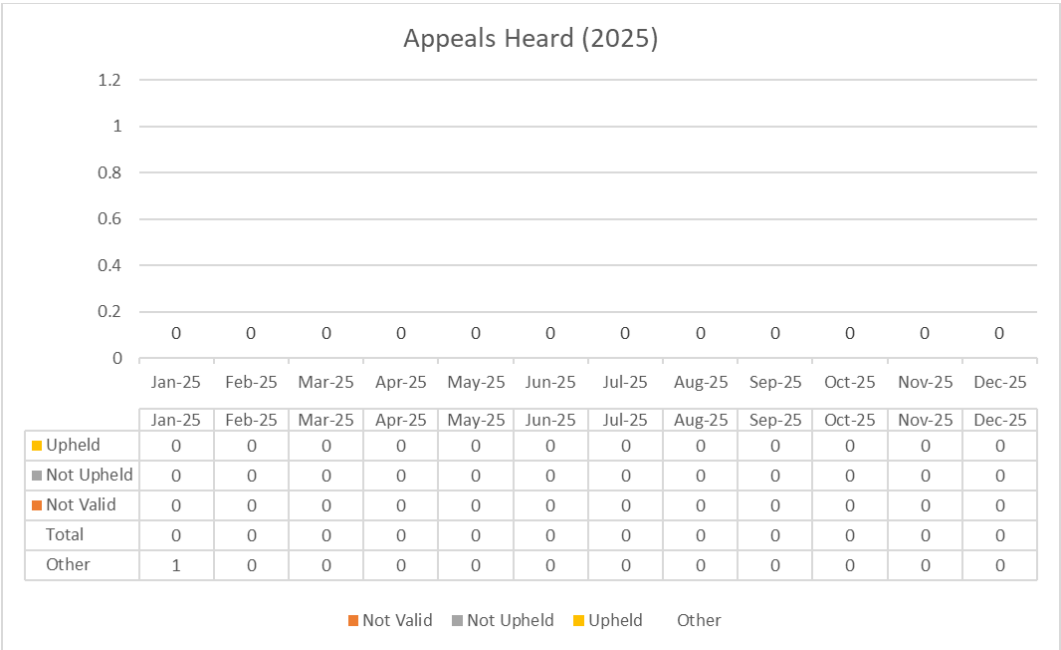


Figure 7: Disciplinary Appeals in 2025

7 National Constitutional Committee

- 7.1. To date, in 2025, no cases have been determined by hearings of the National Constitutional Committee.
- 7.2. 4 members lapsed or resigned before a hearing. Of these, one resigned after the paperwork was submitted
- 7.3. There are currently 17 cases awaiting a hearing. Of these, 15 individuals have been served with their bundles and is awaiting a hearing, and the paperwork for the other 2 cases are being prepared by staff.

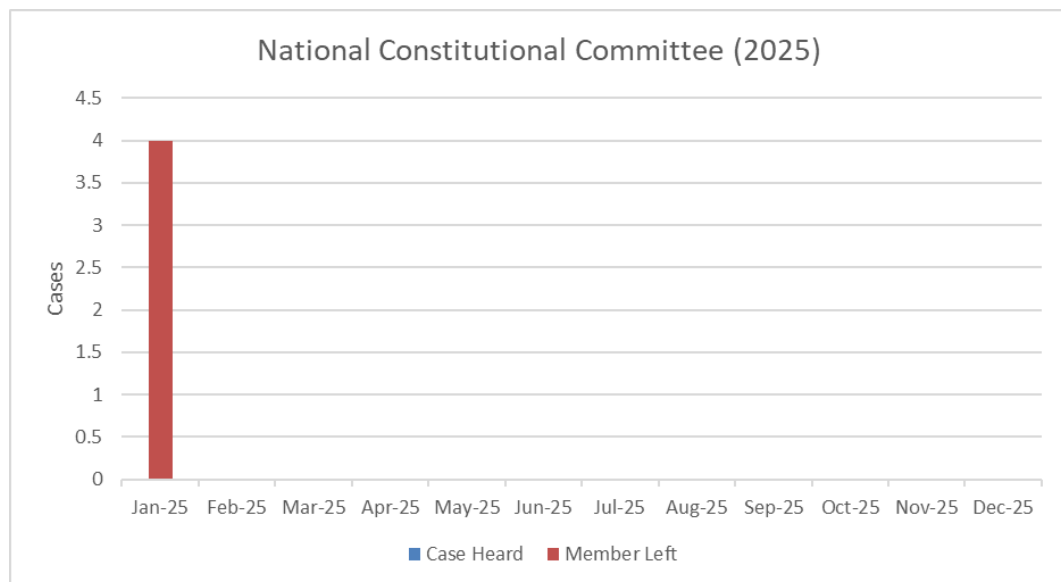


Figure 8: NCC cases determined in 2025

8 Independent Complaints Board

- 8.1. To date, in 2025, no cases have been determined by the Independent Complaints Board.
- 8.2. Additionally, 1 case has concluded because the case was referred back to the NEC; and 1 case has concluded because the member resigned.
- 8.3. There are 5 cases remaining. The paperwork for all 5 cases has been submitted to the ICB and are awaiting determination by a panel.

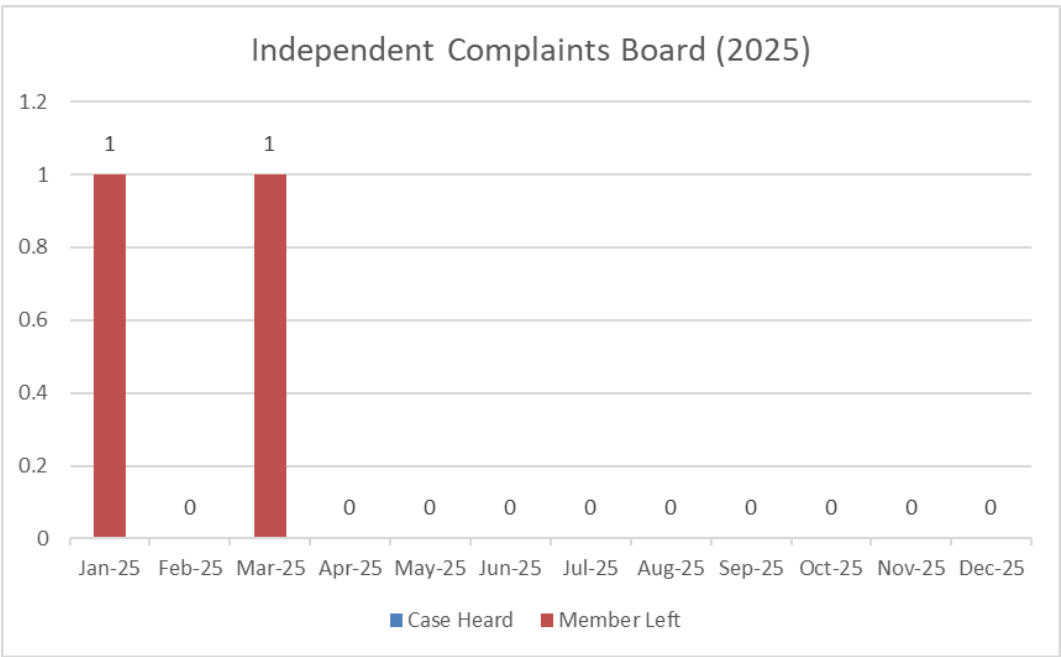


Figure 9: Independent Review Board in 2025
